### Flotilla Nets New Boat Crew

After months of intensive training, Flotilla 4 now has a new boat crew ready and qualified to go. With spring weather in April, the trainees went on the water for a weekend of on-the-water training to take the skills learned in the classroom and dry dock and put them to action on the lake.

For the past few months, students have learned about towing other boats, rescuing people from the water, navigating, and other basic seamanship skills. Trainees have performed training during the day and at night. They trained in dry dock and on the water. They performed a boat crew swim in a pool to prove that they could stay afloat for 15 minutes.

This month Division Qualification Examiner, Pauline Longnecker, came to the area and was able to put almost half of our trainees through their paces. Travis Daniels was tested and qualified as a coxswain on the Lady Grace. Chuck Brudtkuhl, John Halbrook, Doug Jansen, Paul Faganel, Wendy Faganel and Norma Newton tested for and became qualified as boat crew members.

The qualification exam consisted of a dockside oral exam of each trainee to ensure that they had a basic understanding of the boat crew skills. Then it was time to go on the water and do skills demonstrations. Trainees participated in stern tow, side tow, and man overboard evolutions to demonstrate their understanding of many different skills.

After several different sorties, the trainees were able to go out and prove their worth. There are still several flotilla members who are preparing for the next round of qualification exams so that they too will be qualified. By the end of the season, the flotilla should have a large pool of crew members and more coxswains to draw from.

### **Being Semper Paratus Takes Practice**

With hurricane season right around the corner, Coast Guard commands across the nation will soon be reviewing and readying their response plans. Part of that cycle will be a series of exercises that will ensure the Coast Guard is in fighting trim. In support of our overall preparedness goals, the Coast Guard has undertaken an effort to improve its corps of exercise professionals. The Coast Guard recently graduated its 115th federally-certified Master Exercise Practitioner as a result of a growing partnership with FEMA's Emergency Management Institute in Emmitsburg, Maryland. The Coast Guard is now the 2nd leading federal agency in number of graduates (Customs & Border Protection is 1st).

For the past two years the Office of Contingency Exercises (CG-535) has sponsored special convenings of the Master Exercise Practitioner Program (MEPP) course to raise the proficiency of Coast Guard Preparedness Staff nationwide. The MEPP program is the senior-most course offered by the federal government for the design and conduct of exercises. The Coast Guard and the network of port communities we serve benefit from having this expert cadre distributed throughout the operational Coast Guard. MEPP skills complement the various Coast Guard and DoD preparedness courses taken by our planning and exercise staffs. The combined competencies guide our unit commands to more meaningful exercises that improve preparedness for All Threats - All Hazards.

So, what does a MEPP course entail? Through a comprehensive series of three one-week sessions (that include professional demonstrations in between), the MEPP students develop hands-on expertise in multiyear exercise program management, design and conduct of tabletop, functional, and full scale exercises. The MEPP course is based on the DHS Homeland Security Exercise and Evaluation Program (HSEEP), which provides a common approach for all levels of government. Students receive a healthy understanding of the many emergency management disciplines of federal, state, and local agencies that have key roles during incident responses. The MEPP course is taught by FEMA at either the Emergency Management Institute or the Center for Domestic Preparedness (Anniston, AL). As Coast Guard graduate numbers increased, subsequent courses included Coast Guard MEPP graduates as instructors, working in tandem with FEMA instructors, to tailor the curriculum to CG-specific examples and topics.

The Coast Guard exercise program plans to continue this beneficial partnership with FEMA, with the goal of providing each of our major field commands (Sectors, Districts and Areas) with a certified Practitioner. Additionally, all Exercise Support Team professionals will be sent to this course of instruction. To date, we are 95% complete in fulfilling that goal. Additionally, we will continue to pursue opportunities for our field commands to assist local agency partners obtain seats in MEPP to increase our interoperability, interagency coordination, and collective contingency preparedness."

### Vessel Safety Checks Off And Running

The flotilla received its first allotment of Vessel Safety Check decals and has been off to the lake to start doing inspections. This year John Hawkinson, Ralph Tomlinson, and Suzanne Tomlinson have all completed VSCs. To date the flotilla has conducted over 20 inspections and has 2 members who have met the requirements to become Vessel Examiners; Chuck Brudtkuhl and Doug Jansen.

This year we are trying to increase the number of VSCs conducted. In 2008 the flotilla is credited with 114 VSCs. This year we want to exceed 200 VSCs.

To do this we are scheduling more dates to conduct VSCs and will also try to do them on our operational weekends.

We will also need more qualified Vessel Examiners. If you are interested in becoming a Vessel Examiner, please contact Suzanne Tomlinson our FSO-VE. The primary requirement is to pass the written test with a score of 90% and conduct five VSCs with a qualified Vessel Examiner.

# Life Jacket Zone Ramp Painting

The lowa Department of Natural Resources and the United States Coast Guard Auxiliary have partnered in a program to increase public awareness of boating safety. This spring, signs are being painted on all DNR maintained boat ramps reminding boaters that life jackets need to be worn when boating.

The signs declare the ramp to be a "life jacket zone". The first set of Coast Guard Auxiliary volunteers, Flotilla 4 of Des Moines, joined Susan and Donise of the Iowa DNR at Big Creek State Park to begin the painting project. After dividing up the paint, templates, food and other essentials, two groups set out to various state parks. Susan pointed out which parks and where each boat ramp was located in the park.

"This will help to remind boaters to protect everyone aboard their boat by wearing life jackets."

When painting just the third sign of many, a boater and his son appeared at the ramp for a little fishing. They both donned their jackets, and Alex Whitney modeled his for the group. Remember that lowa's new law is that any child 12 or younger is required to wear a life jacket.

"Painting a large 'Life Jacket Zone' sign directly on the ramps will help to remind boaters to protect everyone aboard their boat by wearing life jackets." says Auxilarist Wendy Faganel, Auxiliary project coordinator.

The painting lasted until nightfall, with over 24 ramps being painted today with more to come at a later date.
