They were able to radio Birdland Base who relayed to our two patrol vessels. Pauline and Ron Longnecker on their Personal Watercraft were able to rescue one while David Mote, Jim Berry, Gary Neel, and Jose Medina secured the other two. Communications was handed off to Mission Base at Sycamore access who coordinated the SAR with Sector Upper Mississippi River.

Teamwork involving all four mission elements (shore or ground patrol, surface patrol, communications and mission management) were necessary to make this a success. A New Boat For Flotilla 4

In September it was announced that Flotilla 4 will now have a new vessel available for use for the Spring 2009 season. This new boat is a 23' Sea Ray Laguna Center Console. It is equipped with radar, GPS, Comm radios, and twin 135 HP outboard motors. It's top speed will be nearly 60 Knots. Mr. Daniels towed the new boat to the Flotilla Business Meeting on September 14th for Flotilla members to look at. Over the winter months it will get some TLC and get outfitted with the necessary gear to be made a suitable Coast Guard Auxiliary facility this spring. It is planned that this facility will be available in addition to 2 other Jon Boats, 2 PWC's, and a pontoon boat for multi-mission patrols and SAR's in Flotilla 4's area of responsibility.

SEOC Liaison Recognized by SUMR

As you know I have been in this Sector for only a short time, but in that time I have been impressed by the support and professionalism of 8 Western Rivers' Auxiliarists. Your assistance to the Sector has been invaluable and is very much appreciated.

During the past month, I have reviewed the lessons learned from the massive flooding in June. One of the success stories which stand out is that of the Auxiliarists who support the lowa State Emergency Operations Center (SEOC). For those of you who are unaware of this team, let me provide you with some background information about them. These Auxiliarists volunteered to work with the lowa SEOC and have been trained as a part of that organization. As such, when Sector dispatched a Coast Guard Liaison officer to the lowa SEOC during the flooding this team supported him. This assistance was invaluable to ensure rapid support to the affected areas.

Based on the success of this team, I would like to establish an SEOC support team at each of the SEOC's in Sector Upper Mississippi River's (SUMR) area of Responsibility (AOR). The principal function of these teams would be to assist SUMR during emergencies by acting as a member of the Coast Guard Liaison Support Team assigned to the SEOC; working under the direct supervision of an assigned Coast Guard Liaison Officer. All teams would perform their duties under the supervision of the Incident Management Division at Sector UMR. Each team would train with the SEOC to ensure familiarity with systems, personnel, types of emergencies, etc; participate in SEOC Major Exercises; and, participate in SEOC Planning Evolutions (not as the decision maker, but as the communications link with SUMR).

The specific qualifications I am looking for in each volunteer are:

- ICS 100, ICS 200, IS 700, & IS 800; with ICS 300 & ICS 400 preferred;
- Some computer skills are necessary.
- Co-located near the SEOC;
- Willing to serve during emergencies;
- Willing to make a significant investment in personnel time for: Training; Exercises; and, Planning.

These teams are necessary to cover a gap in our support organization which exists between SUMR and the other ten (10) SEOCs in our AOR. This program is essential to ensuring that we fulfill our responsibilities in emergency management and I look forward to working with you on making this a success.

The people at "<u>The Personal Retriever</u>" feel that they have a superior product. Their disk based device is thrown like a Frisbee, it has 100 feet of line wound inside of the disk, and the most interesting part is the fact that the disc floats. This device has been certified by the Coast Guard as a type V personal flotation device. They have sent us one to try out. We only have this device for the next few weeks, but in that short time we will put the retriever through its paces to see what it can do.
